

OFDA Provides Scholarships for Aspiring Funeral Service Professionals

Each year, OFDA is fortunate to provide scholastic assistance to students pursuing a career in funeral service. In 2017, we received 14 completed applications, and our committee was greatly encouraged by the group of prospective funeral directors and embalmers. Your financial support permitted distribution of awards to five deserving recipients.

The OFDA Scholastic Assistance Committee (SAC) application will again be available online as of March 26, and the submission deadline is July 27. Students enrolled in a mortuary science program during the 2018-19 academic year are eligible (student must be registered for fall 2018 semester). The SAC will conduct a mandatory in-person interview for selected applicants in mid- to late August 2018 at the OFDA headquarters in Columbus, Ohio. Scholarship awards are paid during the students' final two terms.

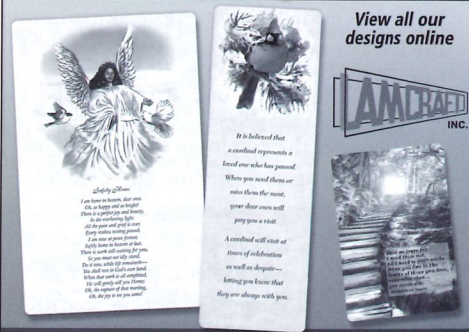
